LEGISLATIVE PROGRAM

ISACo prioritizes building constructive and long-term relationships with policymakers at the state and federal levels to achieve successful outcomes for Illinois counties. Every year, ISACo develops and introduces a proactive legislative agenda to provide solutions to challenges confronting counties.

ISACo reviews thousands of introduced bills each year. During the 2023 spring legislative session, almost 6,700 bills were filed. This excludes resolutions and proposed constitutional amendments. In total, 567 bills were approved by both chambers. Put another way, 8.4% of introduced House and Senate bills made it to the Governor's desk. ISACo tracked almost 1,000 bills and took official positions of support or opposition to legislation 125 times during the 2023 spring session.

Communicating news and information about these issues is a priority for ISACo. Making this information available to county officials and staff in a timely manner increases the likelihood of achieving favorable policy outcomes for counties.

ISACo Legislative Agenda

ISACo staff engages with our members, committees and leadership to identify challenges and solutions for Illinois counties. The solutions become the basis for our annual legislative agendas.

Bill Tracking and Legislative Positions

ISACo reviews and analyzes thousands of bills filed by legislators to identify those that will affect county government. ISACo conveys our position on each bill directly to legislators and frequently files witness slips and provides testimony in support or opposition to proposals in legislative committees.



Legislative Communications

ISACo communicates legislative activity to our members using various reports. These include our weekly ***News and Views e-newsletter***, our annual ***Public Acts Report***, our annual ***State Mandates Report*** and our ***Federal Legislative Update***.

ISACo also researches policy issues and publishes Fact Sheets, Policy Briefs and special memoranda on these issues

ISACo COMMUNICATIONS

- ▶ ***News and Views*** e-newsletters- ISACo publishes content on a weekly basis each year. Each of these e-newsletters are available on ISACo's website.
- ▶ The ***County Quarterly*** is mailed to county officials and interested parties throughout Illinois. It is also available on ISACo's website.
- ▶ ISACo provides a compendium of Attorney General opinions relevant to counties. This information is available on ISACo's website. ISACo publishes county job listings on our website.
- ▶ ISACo is committed to making resources available to Illinois counties. To this end, we have resource pages on issues such as the SAFE-T Act, Clean Energy Jobs Act, State and Local Fiscal and Recovery Funds, Infrastructure Investment and Jobs Act.

CAUCUSES AND COMMITTEES

ISACo offers the following opportunities for county officials and staff to collaborate and discuss common challenges and share ideas for the betterment of county government.

Cook and Collar County Caucus

The Cook and Collar County Caucus (CCCo) consists of the elected President, Chair or Executive from the member counties of Cook, DuPage, Lake, Will, Kane, McHenry and Kendall Counties. The Caucus is governed by its own rules or by-laws.

Large County Board Caucus

The Large County Board Caucus (LCBC) consists of elected Presidents, Chairs or Executives as well as County Board Members from Member Counties with a population exceeding 100,000 residents as determined by the last federal census. The Caucus is governed by its own rules or by-laws.

Rural Action Caucus

The Rural Action Caucus (RAC) consists of elected Chairs and Executives as well as County Board Members from Member Counties with a population under 100,000 residents as determined by the last federal census. Any county, however, can request to be a member regardless of population. The Caucus is governed by its own rules or by-laws.

Legislative Committee

Membership on the Legislative Committee is open to any county official or staff member who applies and is approved by ISACo's President for membership on the Committee.


Policy Committees
