Legislative Advocacy

More than ever, Illinois counties need a strong advocate at the Statehouse and on Capitol Hill. ISACo pursues proactive and aggressive legislative strategies to provide counties with the tools needed to fulfill their important mission.

ISACo's legislative program includes the following:

- Developing an annual legislative agenda that enhances county authority and capacity to solve local problems.
- Reviewing and taking positions on legislation to expand county authority while fighting against unfunded state mandates and preemptions of local authority.
- Monitoring and influencing actions taken by state agencies, boards, commissions and task forces.
- Publishing a weekly e-newsletter during the legislative session that informs county officials about legislation of interest to counties being considered in Springfield and Washington, DC.

Education and Networking

ISACo is planning training seminars designed to fully-equip county officials to serve their constituents at the highest level possible. Session topics under discussion include the following:
